

NORMS FOR THE PRESENTATION OF MANUSCRIPTS

| <i>Author's name</i> | The name(s) of the author(s) must appear as the author wishes it to be published. |
| <i>ORCID</i> | The ORCID number of each author must be informed. |
| <i>Title</i> | Article titles and subtitles cannot exceed 80 characters with spaces. |
| <i>Abstract</i> | All texts, with the exception of book reviews, must be accompanied by an abstract in the language of the article containing a maximum of 800 characters with spaces, with the objective, method, results and conclusions. The line spacing must be 1.5 and there should be no space between paragraphs, acronyms or references. |
| <i>Keywords</i> | At the end of the abstracts, a maximum of four keywords (descriptors) of the text content must be indicated, which must be searched in the Thesaurus Brasileiro de Educação , in the UNESCO – IBE Education Thesaurus or in the European Education Thesaurus . |
| <i>Page size</i> | A4 |
| <i>Margins</i> | 2,54 cm on all margins. |
| <i>Font</i> | Times New Roman, size 12. |
| <i>Line spacing</i> | 1.5 line spacing. No space (before or after) between paragraphs. |
| <i>Length of the text</i> | Articles may not exceed 63,300 characters with spaces, including tables or figures, annexes or appendices and references. The maximum length of the review is 14,550 characters with spaces. |
| <i>Acronyms and abbreviations</i> | The acronyms should be extended when first mentioned in the article. <i>E.g.</i> : Organisation for Economic Co-operation and Development (OECD). Pronounceable acronyms with more than three letters must be written in upper and lower case. <i>E.g.</i> : Exame Nacional do Ensino Médio [National High School Exam] (Enem). |

| <i>Footnotes</i> | Footnotes should be avoided and used only when strictly necessary, preferably without exceeding three lines. Consecutive note numbering will be used within the text. |
| <i>Tables and figures</i> | <p>Text illustrations should be classified into tables and figures only. Tables include tables and charts regardless of the nature of the illustrated information (quantitative or qualitative). Figures, on the other hand, include images, graphs, maps, etc.</p> <p>All illustrations must be in editable format in the Word file. The figures, in addition to being included in the article, must be sent in separate files, as supplementary documents, with a resolution of at least 300 DPIs, and JPG or PNG extension.</p> <p>All tables and figures must be numbered with Arabic numerals, with titles (positioned above) standardized as to the format and terms used. Below them, the source of the data (referring to the bibliographic references) must be indicated, with authorship and year, even if it is prepared by the authors themselves (Source: Authors' elaboration).</p> <p>In the PDF version, tables and figures must be inserted in the position where they will be published.</p> |
| <i>Statistical methodology</i> | <p>The statistical methodology used must be described in detail so that the results can be replicated by a reader with experience in the subject and access to the original data. On the other hand, the use of excessively technical language should be avoided, aiming to present the methodological description with sufficient clarity so that a reader not specialized in the subject can also understand it.</p> <p>These recommendations translate mainly into the following measures:</p> <ul style="list-style-type: none"> • provide details on experimental units, randomization and procedures samples; • describe and/or provide access to the research collection instruments; • indicate all descriptive and inferential techniques used, providing bibliographic references whenever necessary; • present the quantitative results with their respective measures of uncertainty (confidence intervals, p-values, etc.); • adopt a level of accuracy in the presentation of data and results (for example, number of decimal places) standardized and consistent with the possibilities of the research; • use graphical resources and tables whenever these elements can facilitate the organization and synthesis of the data and the understanding of the results; • discuss the reasonableness of the results obtained and report possible limitations of the methods used; • define the technical terms, mathematical symbols and acronyms presented in the article; • specify the statistical software used. |
| <i>In-text citation</i> | <p>Short literal citations, up to 40 words, must be integrated into the text, in quotation marks, followed by parentheses with the author's surname, in upper and lower case, year of publication and page number. Citations with more than 40 words should come in a separate paragraph, with indentation to the left of 1.27 cm, spacing between lines of 1.5 and size 12 font.</p> <p>References without literal citation are incorporated into the text, without the need to inform the page.</p> <p>Do not use <i>idem</i>, <i>ibidem</i> or <i>op. cit.</i></p> <p>For more information, see https://apastyle.apa.org/style-grammar-guidelines/citations/quotations</p> |

| <i>Financing</i> | In case the work is funded by funding agencies, the author must inform, in the item "Acknowledgments". Note: this information must be included only in the complete and identified version in Word. |
| <i>References</i> | The references, restricted only to the works cited in the text, must come at the end of the article and follow the 7 th edition of the <i>Publication manual of the American Psychological Association</i> (APA), following the alphabetical order of the first author's surname, in 1.5 line spacing and with 1.27 cm offset from the second line. | <i>Note on authorship</i> | For texts with two or more authors, the contribution of each of the authors in the preparation of the article must be included in the item "Note on authorship". <i>Cadernos de Pesquisa</i> adopts the CRediT taxonomy (https://credit.niso.org/) and indicates that at least two authorship criteria are used: a. Actively participate in the discussion of results; b. Review and approval of the final version of the work. |
| <i>Data availability statement</i> | In the submission process, complete the Research data availability form , indicating whether the research data is or will be available. This information must be included in the item "Data availability statement" in the manuscript. |
| <i>Data repository citation</i> | If the research data is already in a repository, the author must inform in the item "Data availability statement" and insert it in the list of references. |
